

## 2023 WRL PLAYOFF INFORMATION

Welcome to the 2023 WRL Playoffs! You received game sheets for the playoffs in your initial package that would have been supplied at your Association meeting at the beginning of the season. Please refer to the following regarding result reporting and protest procedures. Also, please pay close attention to rule & procedure regarding temporary player requests.

### REPORTING OF RESULTS

- a) **Home team** will supply the game sheet. Teams are to refer to the playoff schedule prior to their game to determine who is the home team and who is to supply the game sheet for that game.
- b) **Winning team** takes the white copy and **MUST** send a legible copy of the game sheet to the Loop Convenor email address **AND** enter the game score on the WRL website (as you did during regular season) **NO LATER THAN TWO HOURS AFTER THE END OF THE GAME**. Failure to do so may result in loss of game. Please keep all white copies of game sheets until March 15th as council may request the original copies.

### PROTESTS (page 45 WRL Rule Book)

Protests are to be reported to your WRL Representative and the Playoff Coordinator, Monique Fehr (**204-801-3020 / [playoff-coordinator@winnipeggringette.com](mailto:playoff-coordinator@winnipeggringette.com)**), immediately following the game of protest. Form is attached or available online.

- a) No protest will be considered over the on-ice official's decision as to fact such as scoring of goals or blue line infractions, nor over the judgment of the on-ice officials.
- b) Protests are to be filled out on forms, either attached or from the WRL website.
- c) The protest, signed by a qualified team member, must be delivered in writing to the league President or other WRL Executive within **four hours**.
- d) Any protest delivered shall contain ONE protestable reason for protest and \$100.00 (cheque, cash or e-transfer to WRL Treasurer only), along with their game sheet.

### TEMPORARY PLAYERS (page 40 WRL Rule Book)

**THERE ARE NO TEMPORARY PLAYERS ALLOWED IN THE PLAYOFFS.** Under extenuating circumstances, use of a temporary player **MAY** be approved by the WRL Playoff Committee.
